COMMUNITY TECHNICAL PREVIEW AGREEMENT

Software: Visual COBOL® for Eclipse – Android Technical Preview (together with the written materials and guides accompanying the product ("Documentation") the "Software").

- 1. LICENSE:** Micro Focus grants Customer a nontransferable and nonexclusive right to use the Software for non-productive, internal business purposes related to testing and evaluation of the Software during the term of this Agreement; and to use the associated documentation and related information (if any) solely in support of that use. Customer must reproduce and include any copyrights, trademark notice, legends and logos on all copies of the Software made by Customer. Customer will use the Software solely for test and evaluation purposes. Customer will not make productive use of or modify or reverse engineer the Software. Customer may copy the Software only for archival use relating to the testing and evaluation of the Software. Customer will provide at least the same protection from unauthorized use or copying as industry standards.
- 2. TERM/TERMINATION OF AGREEMENT:** The Effective Date of this Agreement is as stated above. Either party may immediately terminate this Agreement prior to the termination above by giving written notice of termination to the other party. Upon the termination of this Agreement, Customer will cease to use the Software and will return all copies of the Software and associated documentation and related information to Micro Focus and destroy any archival copies of the Software that have been made.
- 3. NO WARRANTIES:** Customer understands that (i) the Software is still undergoing development and pre-release testing; (ii) as a pre-release version, Micro Focus has not made the Software generally available; (iii) the Software most likely will contain bugs, defects and errors; (iv) the Software is not expected to function fully upon installation; and (v) all positioning, pricing plans, format, commercial terms or other commercial information are subject to change without notice and may not be generally available as projected. As a result, Customer agrees that Customer bears the sole and entire risk as to the quality and performance and has complete liability for use of the Software. THIS SOFTWARE IS PROVIDED "AS IS" AND ALL IMPLIED WARRANTIES, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE SHALL NOT APPLY. This Software is unsupported and Micro Focus shall offer no support for the Software until it becomes generally available. Customer agrees to keep confidential and not disclose any information regarding this Agreement unless such information is or becomes part of the public domain through no fault of Customer.
- 4. FEEDBACK:** Micro Focus may from time to time request suggestions, feedback or other information from Customer on Proprietary Information or on released or unreleased software or hardware. Any suggestions, feedback or other disclosures made by Customer are and shall be entirely voluntary on Customer's part and shall not create any obligations on the part of Micro Focus or a confidential relationship between Customer and Micro Focus. Instead, Micro Focus shall be free to disclose and use Customer's suggestions, feedback or other information as Micro Focus sees fit, entirely without obligation of any kind to Customer.
- 5. CONFIDENTIALITY AND PROPRIETARY RIGHTS:** In the course of using the Software and performing any tests or evaluations, Customer will obtain information relating to the Software and to Micro Focus, such information is of a confidential and proprietary nature to Micro Focus ("Proprietary Information"), and Customer agrees to maintain in strictest confidence and trust all such Proprietary Information, and not use such Proprietary Information other than in the course of any such testing and evaluation or disclose any such Proprietary Information without the prior written consent of Micro Focus.
- 6. LIMITATION OF LIABILITY:** IN NO EVENT WILL MICRO FOCUS BE LIABLE FOR ANY DAMAGES WHATSOEVER IN CONNECTION WITH THIS AGREEMENT WHETHER THEY BE DIRECT, INDIRECT, INCIDENTAL, SPECIAL CONSEQUENTIAL OR OTHER DAMAGES ARISING OUT OF THE USE OF THE SOFTWARE, WHETHER OR NOT INFORMED OF THE POSSIBILITIES OF DAMAGES IN ADVANCE. THESE LIMITATIONS APPLY TO ALL CAUSES OF ACTION, INCLUDING BREACH OF CONTRACT, BREACH OF WARRANTY, NEGLIGENCE, STRICT LIABILITY, MISREPRESENTATION AND OTHER TORTS. 8. USE BY GOVERNMENT: If Software is being acquired by or on behalf of the U.S. Government or by a U.S. Government prime contractor or subcontractor (at any tier), then the Government's rights in Software and accompanying Documentation will be only as set forth in this Agreement in accordance with 48 CFR 227.7201 through 227.7202-4 (for Department of Defense (DOD) acquisitions) and with 48 CFR 2.101 and 12.212 (for non-DOD acquisitions). 9. ASSIGNMENT OR DELEGATION: Customer may not assign or transfer this Agreement or any rights thereunder and may not delegate any duties under this Agreement without Micro Focus' prior written consent. Any attempt to assign or delegate this Agreement without such consent will be null and void. Micro Focus may transfer or assign this Agreement or any rights thereunder at any time without notice.

10. EXCLUSIVE AGREEMENT: THIS AGREEMENT IS THE COMPLETE AND EXCLUSIVE STATEMENT OF AGREEMENT BETWEEN THE PARTIES AND SUPERSEDES ALL PROPOSALS, COMMUNICATIONS, PURCHASE ORDERS AND PRIOR AGREEMENTS, VERBAL, OR WRITTEN, BETWEEN THE PARTIES. This Agreement shall not be changed, modified or altered in any manner except by an instrument in writing and signed by both parties. The terms and conditions of this Agreement shall supercede all terms of any unsigned or "shrinkwrap" license included in the Software.

11. REPORTING OF ERRORS: Customer agrees to require a representative of Customer to promptly report all errors encountered during any use, testing or evaluation directly to Micro Focus and if necessary, supply a diskette with a sample program that demonstrates the problem. Subject to Section 4, when Customer completes its use, testing or evaluation, Customer agrees to furnish Micro Focus with a written evaluation of the installability, functionality, performance and usability of the Software and documentation provided.

12. PUBLICITY: Customer hereby authorizes Micro Focus to disclose the fact that Customer has entered into this Agreement and is undertaking use, testing and evaluation of the Software, in connection Micro Focus' publicity and promotion efforts for the Software and for subsequent releases and versions thereof. Unless otherwise permitted by law or in a separate written agreement between Micro Focus and Customer, Micro Focus will not use the name of Customer in any other way or for any other purpose without the prior written consent of Customer.

13. GOVERNING LAW: This Agreement, and all matters arising out of or relating to this Agreement, shall be governed by the laws of the State of Maryland, without regard to its choice of law provisions.
